

WILT Sunny 103.7
Concert Hookup Sweepstakes 2018
Official Rules

1. **GENERAL:** No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or restricted by law. All applicable federal, state, and local regulations govern this sweepstakes.

2. **ELIGIBILITY:** The Concert Hookup Sweepstakes (“Sweepstakes,” “Grand Prize”) is open only to legal U.S. and North Carolina residents who reside or work within the Beaufort, Bladen, Brunswick, Carteret, Columbus, Craven, Duplin, Green, Johnston, Jones, Lenoir, New Hanover, Onslow, Pamlico, Pender, Pitt, Sampson, and Wayne counties and who are 18 years of age or older at the time of entry. Limit one winner per household. Limit one winner per immediate family. Prizes are non-transferable. Employees of Sunny 103.7, Sunrise Broadcasting, LLC or Capitol Broadcasting Company, Inc., Sun and Fun Media, and their respective advertising and promotional agencies, and each of their parents, subsidiaries, affiliates, representatives, and agents, and their officers, directors, and employees (collectively, “Sweepstakes Entities”), members of their immediate families, and the members of the same households of such individuals are not eligible. The sweepstakes entry period begins on April 12, 2018 in the 8am hour and ends on May 18, 2018 in the 4pm hour. Qualifiers will be chosen four times a day, Monday – Friday, during the contesting period during the 8 am, 11 am, 1 pm and 4 pm hour.

There is one method of entry. : Participants must listen to WILT for the Concert Hookup Sweepstakes sounder which will air up to four times a day between 8am and 5pm. Participants must call (910) 790-1037. Calls to any other WILT number will not qualify. Caller number seven (7) after the sounder airs will be qualified for the Concert Hookup Sweepstakes. There will be a total of one hundred (100) qualifiers chosen by this method. Entrants entering by phone will be charged standard phone call rates for calls according to the terms and conditions in their calling plan. Wireless services are not available in all areas.

HOW TO WIN: All eligible qualifiers will be invited to participate in the Concert Hookup Sweepstakes event. On May 19, 2018 from 11a-1p all qualifiers are invited to attend the sweepstakes event located at – Bill’s Front Porch Pub and Brewery, 4238 Market St, Wilmington, NC 28403. All qualifiers must check in beginning at 11am and be checked in with Sunny 103.7 staff no later than 12:30 pm. Qualifier must be present to win. No stand ins allowed. All qualifiers in attendance at the sweepstakes event will have their names entered in a registration box. Ten (10) finalist names will be pulled from the registration box. Each finalist will be offered a gift that will contain a winning prize that will include something “special” to identify it. One of the gifts will contain the winning tickets for the concert experience of their choice from all identified, eligible concerts.
